

**RESOLUTION 2000-12-07.1**

**Rates, Charges, Fees and Penalties for Fiscal Year 2001**

WHEREAS, the Colorado Centre Metropolitan District wishes to adopt a schedule for "Rates, Charges, Fees and Penalties" for fiscal year 2001.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Colorado Centre Metropolitan District that the "Rates, Charges, Fees and Penalties" for the District as of January 1, 2001 shall be as follows:

2000 Restricted Levy	100.000 mills	Levied on "Developer Owned Property" only, as defined in the plan of re-organization.
Drainage and Bridge Fee	As per County	Payable at time of plat approval. El Paso County collecting this fee now.
Development Fee	\$0.30 per s.f.	Payable per square foot of gross commercial and industrial building area for properties in El Paso County not covered by the Annexation Agreement to Colorado Springs.
Landscaping Fee	\$50 per unit	Payable per single family equivalent dwelling unit at time of building permit for the enhancement of ROW areas selected by the District.
Plan Check Fee	\$100 per unit	Payable per single or multiple family dwelling unit at time of preliminary plat approval by the District. The charge will be repeated for the final plat, unless final platting is completed within 180 days of the preliminary plat, regardless of reason for delay.
	\$500 per acre	Payable per gross acre of commercial and industrial property at time of preliminary plat approval by the District. The charge will be repeated for the final plat, unless final platting is completed within 180 days of the preliminary plat, regardless of reason for delay.
Inspection Fee	\$100 per unit	Payable per single or multiple family dwelling unit at time of purchase of water and sewer tap from the District. The charge will be re-assessed, unless construction is completed within 360 days of the original building permit, regardless of reason for delay.
	\$500 per acre	Payable per gross acre of commercial and industrial property at time of water and sewer tap purchase from the District. The charge will be re-assessed, unless construction is completed within 360 days of the original building permit, regardless of reason for delay.

**WATER AND WASTEWATER TAP FEES ARE PAYABLE TO THE DISTRICT AT THE BUILDING PERMIT STAGE**

**Water and Wastewater tap fees paid shall be good for 12 months from the date they are sold. After said time the taps are lost and their cost is forfeited to the District.**

**Water and Wastewater system improvement fees paid shall be good for 12 months from the date they are sold. After said time the taps are lost and their cost is forfeited to the District.**

Sewer System Improvement Fee	\$1,000.00	Per S.F.E. sewer tap purchased. A S.F.E. sewer tap is based on 15 fixture unit equiv. as set in Appendix A.

## Appendix A

### FIXTURE UNIT EQUIVALENTS

Fixture unit equivalents shall be calculated using the following schedule and shall apply to "stubbed in" or "roughed in" fixture traps as well as those fixtures being installed.
