TO APPROPRIATE SUMS OF MONEY FOR FISCAL YEAR 2008

A RESOLUTION APPROPRIATING SUMS OF MONEY TO THE VARIOUS FUNDS AND AGENCIES, IN THE AMOUNTS AND FOR THE PURPOSE AS SET FORTH BELOW, FOR THE COLORADO CENTRE METROPOLITAN DISTRICT, COLORADO, FOR THE BUDGET YEAR 2008.

WHEREAS, the Board of Directors has adopted the annual budget in accordance with the Local Government Law, on December 6, 2007; and,


